CSR Policy – Aakaar Medical Technologies Ltd. – F.Y. 2025-26

In accordance with the provisions of Section 135 of Companies Act, 2013, read-with Schedule VII of the Companies Act, 2013 and the Companies (Corporate Social Responsibility Policy) Rules, 2013, the Corporate Social Responsibility (CSR) Policy of Aakaar Medical Technologies Ltd ("the Company") was formulated by the Board of Directors of the Company at their meeting held on 27th May, 2025. This policy will be subject to the provisions of the aforesaid Act and Rules (as amended from time to time).

1. Objective

This Policy has been formulated in compliance with Section 135 of the Companies Act, 2013 read along with the applicable rules thereto.

2. Policy Statement

At Aakaar Medical Technologies Ltd, we are committed to integrating ethical, social, and environmental considerations into our business operations, ensuring that our growth contributes positively to society and the planet. Our CSR policy is grounded in the following principles:

2.1. Ethical Conduct and Transparency:

We uphold the highest standards of integrity and transparency in all our business dealings. Our operations comply with all applicable laws and regulations, and we are dedicated to honest communication with our stakeholders.

2.2. Environmental Stewardship:

We recognize our responsibility to the environment and strive to minimize our ecological footprint.

2.3. Social Impact and Community Engagement:

We believe in actively contribute to the well-being of the communities in which we operate. This includes supporting education, promoting health and wellness, and fostering inclusive economic opportunities.

2.4. Fair Labor Practices and Human Rights:

We are dedicated to providing a safe, inclusive, and respectful workplace. Our policies ensure fair wages, non-discrimination, and the protection of human rights.

2.5. Consumer Responsibility:

We prioritize the safety and satisfaction of our customers by offering products that are safe, effective, and ethically produced. We provide clear information about our products and encourage responsible consumption practices.

2.6. Continuous Improvement and Accountability:

We regularly assess our CSR initiatives to ensure they meet our objectives and align with evolving societal expectations. We are committed to continuous improvement and hold ourselves accountable to our stakeholders.

By adhering to this CSR policy, Aakaar Medical Technologies Ltd. [AMTL] aims to be a responsible corporate entity that contributes to sustainable development and the well-being of society.

3. Scope

This Policy shall apply to all CSR projects/ programmes /activities which will be undertaken by the Company in India as per Schedule VII of the Act.

4. Definitions:

1. "Act" means the Companies Act, 2013 including any statutory modification or re-enactment thereof.
2. "Board" means the Board of Directors of the Company.
3. "Board's Report" shall mean report of the Board of Directors prepared in accordance with section 134(3) of the Companies Act, 2013.
4. "Company" means Aakaar Medical Technologies Limited, a Company registered under the Companies Act 1956, having its Registered Office at A-801, Heritage Plaza, Teli Gali Cross Road, Andheri East, Mumbai-400069.
5. "Corporate Social Responsibility (CSR) Activities" means the activities includes but is not limited to:
 1. Projects or programs relating to activities undertaken by the Board of directors of the company as per declared CSR Policy of the company subject to the condition that such policy will cover subjects enumerated in Schedule VII of the Act.

2. However, CSR Activities shall not include the activities being undertaken by the Company in its normal course of business

6. CSR Policy means the Corporate Social Responsibility Policy as set out herein and as amended or modified from time to time.

7. 'Net Profit' means the net profit of the Company as per its financial statement prepared in accordance with applicable provisions of the Act (Section 198), but shall not include the following viz:

1. Any profit arising from any overseas branch or branches of the Company, whether operated as a separate company or otherwise and
2. Any dividend received from other companies in India, which are covered under and complying with the provisions of Section 135 of the Act
Provided that net profit in respect of a financial year for which the relevant financial statements were prepared in accordance with the provisions of the Companies Act, 1956 shall not be required to be re-calculated in accordance with the provisions of the Act.

6. CSR Committee

The Board of Directors of the Company in their meeting held on 27.5.2025 have decided against constituting a CSR Committee since the amount to be spent by the Company under sub-section 5 of Section 135 does not exceed fifty lakh rupees.

The Board of Directors will have the following roles, powers and responsibility:

1. Formulating a Corporate Social Responsibility Policy ("CSR Policy") indicating the activities to be undertaken by the company as specified in Schedule VII of the Act and any amendments therein;
2. to approve the amount of expenditure to be incurred on activities referred to in clause (i);
3. Develop and approve various CSR projects, programs and activities to be undertaken from time to time either directly by the Company or through other entities.
4. Determine modalities of execution of such CSR projects, programs and activities
5. Undertake all necessary steps to implement the CSR activities
6. Authorise and approve CSR expenditure from time to time subject to the limits under sub-section 5 of section 135 of Companies Act 2013.
7. Monitor the CSR Policy and activities from time to time.

8. Carry out all such acts, deeds, matters and things as may be required in connection with aforesaid matters and generally for any matter connected with the CSR policy of the Company.
 9. Ensure that the CSR activities included in this Corporate Social Responsibility Policy are undertaken by the Company.
 10. Ensure that in each financial year the Company spends at least 2% of the average net profits of the company made during the three immediate preceding financial years, calculated in accordance with Section 198 of the Act, in pursuance of its CSR policy.
 11. As per Section 135 of the Act, specify the reasons for under spending the CSR amount in the Board's Report.
8. CSR Activities :
1. Eradicating hunger, poverty and malnutrition, promoting preventive health care and sanitation including contribution to the Swach Bharat Kosh set-up by the Central Government for the promotion of sanitation and making available safe drinking water.
 2. Promoting health, safety and welfare of people.
 3. Promoting education including special education and employment enhancing vocation skills specially among children, women, elderly and differently able and livelihood enhancement projects
 4. Promoting gender equality, empowering women, setting up homes and hostels for women and orphans; setting up old age homes, day care centers and such other facilities for senior citizens and measures for reducing inequalities faced by socially and economically backward groups.
 5. Ensuring environmental sustainability, ecological balance, protection of flora and fauna, animal welfare and agroforestry, conservation of natural resources and maintaining quality of soil, air and water including contribution to the Clean Ganga Fund set-up by the Central Government for rejuvenation of river Ganga
 6. Protection of national heritage, art and culture including restoration of buildings and sites of historical importance and works of art; setting up public library; promotion and development of traditional art and handicrafts
 7. training to promote rural sports, nationally recognised sports, paralympic sports and Olympic sports;
 8. contribution to the Prime Minister's National Relief Fund or any other fund set up by the Central Government for socio-economic development and relief and welfare of the Scheduled Castes, the Scheduled Tribes, other backward classes, minorities and women;

9. contributions or funds provided to technology incubators located within academic institutions which are approved by the Central Government

10. Rural Development Projects.

9. Target Group

The Company shall ensure that in identifying its CSR Projects, preference shall be given to the local area and areas around which the Company operates. However, this shall not bar the Company from pursuing its CSR objects in other areas.

10. CSR Monitoring and Reporting Framework

In compliance with the Act and to ensure funds spent on CSR Activities are creating the desired impact on the ground a comprehensive Monitoring and Reporting framework has been put in place.

The Board shall monitor the implementation of the CSR Policy through periodic reviews of the CSR activities.

The respective CSR personnel will present their annual budgets along with the list of approved CSR activities conducted by the Company to the CSR Committee together with the progress made from time to time as a part of the evaluation process under the monitoring mechanism.

11. CSR Expenditure

The Board of Directors shall endeavor to the best of its efforts that the Company spends, in every financial year, at least two per cent of the average net profits of the Company made during the three immediately preceding financial years and computed in accordance with the provisions of 198 of Companies Act, 2013 read-with the Companies (Corporate Social Responsibility Policy) Rules, 2014.

The CSR activities undertaken in India only shall amount to CSR Expenditure. CSR Expenditure shall include all expenditure including contribution to corpus for CSR activities approved by the Board but does not include any expenditure on an item not in conformity or not in line with activities which fall within the purview of Schedule VII of the Act.

Any surplus arising out of CSR projects, programs and activities shall not form part of the business profits of the Company.

Further, the Company will report reasons for under spending, if any, of the allocated CSR budget of the current financial year in Board's Report under the signatures of the Board of Directors of the Company.

12. Disclosure of the Policy

The CSR policy recommended by the CSR Committee and approved by the Board shall be displayed on the Company's website viz. www.aakaarmedical.in and shall also be disclosed in the Board's report as well.

13. CSR Reporting

The Board's Report of the company shall include an Annual Report on CSR containing particulars specified in Annexure to the CSR Rules as per the prescribed format.

14. Miscellaneous

This policy shall be updated from time to time, by the Company in accordance with the amendments, if any, to the Companies Act, 2013, rules made thereunder or any other applicable enactment for the time being in force.
